

# A spike in Covid-19 cases among **Brazilians and Filipinos**

©Kani City Covid-19 Cases Situation



- · Cases of infection have been increasing, mainly among young people.
- · Despite the fact that foreign residents account for 8% of the city's population, 65% of the infected persons are foreigners and 86% of those foreigners are in elementary and junior high schools.
- · Cluster cases among foreigners are linked to family and friends parties and gatherings.
- · The situation is critical. If it persists, it is going to result in collapse of the local health care and educational systems.
